Angels Initiative Simulation Training

The Angels Initiative is an international initiative aimed at improving stroke care. We aim to do this by creating a community of at least 10,000 stroke centers and stroke ready hospitals across the world by 2030, all working together every day to improve the outcomes patients suffer after a stroke.

As part of this initiative we aim to help hospitals standardize their stroke treatment pathways and reduce the time it takes to treat stroke patients. To do this we would like to implement one of our tools in your hospital (hereinafter referred to as the "Hospital"), namely the process of "dummy patient simulation training" (hereinafter referred to as the "Training"). As part of the Training the stroke team in the Hospital will assign a dummy patient which the stroke team will be asked to treat as they would normally treat any stroke patient.

A team member from the Hospital will be given a GoPro camera and tasked with making a video recording of the first simulated treatment. The Angels Consultant will observe and makes notes. These notes and the video recording will be used in a discussion and referred to in order to point out areas of improvement and areas that the team performed well when compared to international best practice.

A second run is performed after changes or corrective actions have been agreed on to show the team the effect that implementing these changes could have on reducing treatment delays. This is again recorded for reference purposes.

The reason for recording the Training is purely to serve as a reference to show stroke team members what they have done rather than just talking about it. We have found this method extremely effective in the past in terms of motivating positive change.

For this reason we would like to get your permission to perform the Training as well as shoot footage of the simulation we plan to do in your Hospital.

Training performed on simulated stroke patients as part of the Angels Initiative is done purely as a training exercise and is not meant to intervene in any way with the normal treatment of any patients in the Hospital. The Angels Initiative is intended for the support of healthcare and does not constitute an inducement to recommend, prescribe, purchase, supply, sell or administer specific medicinal products.

With this in mind may we ask you to sign the attached location release form giving us the permission to perform the Training and for one of the hospital employees to be able to do the filming of the Training in your hospital.

The video footage generated during the filming will be the property of the Hospital and can be used at your own discretion.
